THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976

No.GH/V/138 of 2012/GPS-1411-1273-L: WHEREAS, under section 41(1) of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") Surat Urban Development Authority (hereinafter referred to as "the said Authority") declared its intention of making of the Draft Town Planning Scheme No. 35 (Kumbhariya-Saroli-Saniyahemad-Devdh) (hereinafter referred to as "the said Draft Scheme").

AND WHEREAS, under section 42(1) of the said Act, the said Authority made and published, duly in the prescribed manner in respect of the area included in the said Draft Scheme

AND WHEREAS, after taking into consideration, objection or suggestion received by the said Authority, the said Authority submitted the said Draft Scheme to the State Government for sanction under section 48(1) of the said Act, in the manner provided therein;

AND WHEREAS, the area of said draft scheme is now included within the Surat Municipal Corporation area;

NOW THEREFORE, in exercise of the powers conferred by section 48(2) of the said Act the, Government of Gujarat hereby:-

(a) Sanction the said Draft Scheme for Surat Municipal Corporation subject to the modifications enumerated in the Schedule appended hereto;

(b) State that the said Draft Scheme shall be kept open for inspection by the public, at the office of the said Authority, during office hours on all working days.

SCHEDULE

While finalizing the said Draft Scheme, the Town Planning Officer shall:

1. Allot final plots in their original plots or in the near vicinity as far as possible. (original plot no. 316, 317, 298, 297, 269, 271)
2. Deduct the Govt. lands as well as private lands at par, with the average deduction.
3. Allot the separate original plot/final plot for State Govt. lands as per revenue records.
4. Allot the separate original plot/final plot for excess lands declare under U.L.C. Act.
5. Correct form F, relevant maps and other matters. (final plot no. 113/a, 113/b)
6. Estimate and include cost of scheme borne by appropriate Authority, under section 52(1)(iv), 77(1)(b) and 77(1)(g) of the said Act as well as determine the period within which the works provided in the scheme shall be completed by the appropriate authority.
7. Carve out the final plots in regular shapes, useable and buildable as per the provisions of the general development control regulation. (Final Plot No. 384, 418, 415, 409, 408, 401, 422, 392, 424, 440, 433, 462, 487 and 495)
8. Decide the ownerships, area and tenure as per the revenue records.
9. Check authenticity of the buildings and shall show the sanctioned layout plans and sanctioned building plans on relevant maps.
10. Make proposal, considering width and the alignment of existing and proposed roads of adjoining area and
11. Decided the alignment and width of 30 mtr. wide road so that it is in sync with the roads in adjoining Town Planning Scheme No.19 (Parvat Magob), No. 17 (Puna) and the development plan.
12. Maintain talavs and water bodies.
13. Reconstitute original plots in such a fashion so that the telephone line, gas line or electricity line does not affect the final plots.
14. While finalizing the said Draft Scheme, the Town Planning Officer shall decide the uses permissible in the final plots allotted for the District Centre, Public Utility etc. in the consultation of the appropriate authority.
15. Allot final plot numbers for the final plots to appropriate authority in consecutive sequence.
16. Decide the percentage of beneficiary for allotted final plot to the appropriate authority with the consultation of appropriate authority.

17. Ensure that the final plot allotted in lieu of original plot in accordance to zone as per development plan and in the same village.
 18. Maintain the reservation of Sports Complex (O/M-53) reserved for SMC as per the sanctioned development plan of SUDA.
 19. Provide appropriate excess with required frontage to final plot no. 487 and 218.
 20. Verify the ownership of Government and Private land and accordingly decide to allot final plot in lieu of original plot no. 189, 296, 297.
 21. In regard of land of block no.118 of village Saroli, before taking any decision for deduction, compare it, on merits, with respect to deduction in block no. 125 of village Kumbhariya.
