THE GUJARAT TOWN PLANNING AND URBAN DEVELOPMENT ACT, 1976

No. GH/V/339 of 2025/UDUHD/AAC/e-File/18/2022/7693/L: WHEREAS, under Government Notification, Urban Development and Urban Housing Department No.GH/V/140 of 2013/TPS-1413-4165-L, dated 30.07.2013 the Government of Gujarat, in exercise of the powers conferred by section 48(2) of the Gujarat Town Planning and Urban Development Act, 1976 (President's Act No. 27 of 1976) (hereinafter referred to as "the said Act") sanctioned the Draft Town Planning Scheme No. 47 (Kholvad-Bhada) (hereinafter referred to as "the said Draft Scheme") submitted by the Surat Urban Development Authority, Surat;

AND WHEREAS, the part area of said draft scheme was included within the jurisdiction of Surat Municipal Corporation vide notification no. NO.KV/46 of 2020/SMN/902019 /99331P, dated.18.06.2020;

AND WHEREAS, in exercise of the powers conferred by section 50 of the said Act, the Government of Gujarat appointed the Town Planning Officer for finalizing the said Draft Scheme;

AND WHEREAS, the Town Planning Officer has submitted, to the Government of Gujarat, the Preliminary Town Planning Scheme No. 47 (Kholvad-Bhada) (hereinafter referred to as "the said Preliminary Scheme") as required under section 52(2) and section 64 of the said Act;

NOW THEREFORE, in exercise of the powers conferred by section-65 of the said Act, the Government of Gujarat hereby: -

- (a) Sanction the said Preliminary Scheme with modifications enumerated in schedule appended hereto;
- (b) State that the said preliminary scheme shall be kept open for the inspection of the public, at the office of Surat Urban Development Authority and Surat Municipal Corporation, during office hours on working days;
- (c) Fix the date of this notification as the date for the purpose of clause (b) of sub-section (2) of the section 65.

SCHEDULE

1. The condition "સંદર મૂળખંડની સામે શાળયેલ અંતિમખંડ/બિલ્ડિંગ ચુનિટમાં શીડેવલોપમેન્ટ કરવામાં આવે ત્યારે યોજનામાં અપનાયેલ અન્ય ખુલ્હી જરૂરીના કપાતના ધોરણ મુજબ કપાત કરી, કપાત થતી જરૂરી સત્તામંડળને સુપ્રત કરવાની રહેશે. The area, boundary and location of the Final Plot No. 109 admeasuring 4691 sq.mtr. allotted in lieu of Original Plot No.109 admeasuring 7818 sq.mtr., is modified as the Final Plot No. 109 admeasuring 2168 sq.mtr. allotted in lieu of Original Plot No.109 admeasuring 3614 sq.mtr., as shown in the accompanying plan and the redistribution statement.

3. The 12.0 mtr. wide road earmarked as A-B-C passing through Original Plot No. 108/1, 108/2, 108/3, 108/4, 108/5, 108/6, 108/7 and Original Plot No. 108/8 is deleted, as shown in the accompanying plan.

4. The area, boundary, location and purpose of the Final Plots shown in Column No.2 and its area shown in Column No. 3, are modified as shown in Column No.4 and 5 respectively of table given below and as shown in the accompanying plan and redistribution statement.
